- 5. Please identify each associate, undergraduate, or graduate degree(s) you hold (degree, school, date and discipline). Please be specific with regard to any degrees in science/engineering/technology.
- 6. Please list the national, state and/or federal bars to which you are admitted, the date admitted, and any other relevant licenses.

- 7. How many years have you been acting as a business arbitrator? As a business mediator?
- 8. In how many business cases have you been appointed as an arbitrator? How many of these were within the last five years? How many resulted in the entry of a final award?
- 9. In how many business cases have you been appointed as a mediator? How many of these were within the last five years? In how many did you conduct a mediation session?
- 10. Please list the appointees to the SVAMC Tech List with whom you have served on a panel or who are familiar with your work as an arbitrator or mediator.
- 11. Is this questionnaire being submitted in response to a recommendation from a current member of the Tech List? If so, who?
- 12. Approximately what percentage of your practice is devoted to each of serving as an arbitrator or mediator, practicing law, teaching, or to another profession (please describe)?

- (d) please briefly describe (to the extent you can without violating your confidentiality obligations) in a representative sample of such mediations what types of technology issues had to be considered by the parties in the mediation.
- 20. Please describe any neutral work by you other than as an arbitrator or mediator (e.g., special master, early neutral evaluator) that focused on or heavily involved science/engineering/technology.
- 21. Language capability may be considered and included in the application process.
- 22. Candidates should indicate in which languages they are fluent, proficient, conversational or at a reading-knowledge level.
- 23. Please list any technology-related certifications you hold from private, government, or military institutions (name of institution, discipline, and approximate date).
- 24. Please describe any work experience you have as a scientist, engineer, or technologist.

- 25. If you have not worked as a scientist, engineer, or technologist, have you had employment (other than as a lawyer) that required you to exercise or which heavily involved science/engineering/technology knowledge/expertise.
- 26. Are you admitted to practice before any patent office as a patent attorney, patent agent, or the like? If so, which office.
- 27. Please list any publications you authored, presentations you made, or teaching you did which focused on or heavily involved technology.
- 28. Please provide names and contact information of up to three references, preferably with whom you have sat as a co-arbitrator or mediator, whom we can contact, and who can speak to your work as an arbitrator or mediator. In choosing references, please focus on people who are familiar with your work in cases that focused on or heavily involved science/engineering/technology. Be careful to choose references who do not have a current conflict or disclosure issue should they be asked to comment about you.
