Rebecca Wardle Associate Bryan Cave Leighton Paisner, London

Rebecca was part of the team acting for BCA in Brown v BCA Trading Limited, in which BCA successfully obtained an order in a contested application to use predictive coding as part of its document review exercise. The use of predictive coding for the purpose of disclosure was tested through to full trial.
